**COUNTY SHARE: NEARLY \$3 MILLION FROM GAMING**  
**First check given to Hulmeville**

The Bucks County Commissioners and the Redevelopment Authority of the County of Bucks (RDA) awarded \$2.9 million in gaming funds to several Bucks County municipalities most likely to be impacted by the new gaming facility at Philadelphia Park in Bensalem. .

A \$25,705 check was presented in March (2008) to Hulmeville Borough to pay for a new police patrol car. It was the first payment made from the Municipal Grant Program.

Late last year, Hulmeville and Bensalem, Bristol, Lower Southampton and Middletown townships each applied for grants ranging from \$19,000 to \$675,000. Middletown applied for a large grant on behalf of the William Penn Fire Co., for the expansion and improvement of two firehouses. The amount was later raised to \$800,000.

Bucks County's 2008 share of gaming revenue generated by Philadelphia Park is one-percent, or \$2.9 million in this first year. The county commissioners designated the RDA to administer the funds through a newly created Municipal Grant Program.

As established by state law, only those municipalities adjacent to the Bensalem gaming facility were eligible to apply for grants. The application/review process was prepared by the RDA and offered, along with application guidance, to the eligible municipalities. Twenty-seven applications were received. The RDA staff processed the applications and also scheduled applicant interviews with the Authority's board of directors, who made the final decision.

All grants awarded in October were related to police and fire, traffic safety, sewer, road repair, building improvements and graffiti cleanup. As part of the process, each municipality is obligated to have its projects "substantially" completed by Dec. 31, 2008.
